

CONSENT TO THE PROCESSING OF PERSONAL DATA

In accordance with Article 9 of the Federal Law of 27.07.2006 N 152-FZ "On Personal Data",

By filling out this application, I, being the subject of personal data, acting freely, of my own free will and in my own interests:

- a) give my consent to the processing of my personal data by the Autonomous Non-Profit Organization Skolkovo Forum (ANO Skolkovo Forum), located at the following address: 143026, Moscow, the territory of the Skolkovo Innovation Center, st. Bolshoi boulevard, 42, building 1, rooms 1525, 1565, performed with and (or) without the use of automation equipment;
- b) confirm the accuracy of the information entered in the application, including information about my identity.

The list of personal data, the consent to the processing of which is given: last name, first name, patronymic, passport information, information about the place of work (company and position), e-mail address, personal phone numbers and other contact information necessary to contact me, a photo, and also any other information contained in the submitted application.

The purpose of processing personal data is:

- to ensure the security of the subject of personal data when visiting the "Open Innovations" Forum (hereinafter - the Forum);
- organization of access control of the personal data subject to the territory in order to participate in the Forum;
- informing the subject of personal data about the working hours and rules for visiting the Forum;
- informing about upcoming events held by ANO Skolkovo Forum, the Skolkovo Foundation and its subsidiary legal entities, as well as other persons;
- informing about significant events in the field of innovative technologies and innovative development of Russia;
- use of personal data in order to demonstrate the functioning of the projects of the Forum participants;
- use of personal data in an advertising campaign dedicated to the Forum, including posting information on the Forum website, on other information resources of ANO Skolkovo Forum and in the media, in printing products, as well as on other advertising platforms of the Forum (this clause applies to the personal data of persons invited as speakers at the Forum).

The list of actions with personal data, for the performance of which consent is given, includes, but is not limited to: collection, recording, systematization, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

In order to achieve the above goals, ANO Skolkovo Forum has the right to transfer personal data to organizations that process personal data on behalf of ANO Skolkovo Forum:

- Skolkovo Foundation;
- LLC "Ruvent";
- LLC "Registration and Accreditation Systems".

The period during which the consent of the subject of personal data is valid, unless otherwise established by the legislation of the Russian Federation: 5 years. The consent of the subject of personal data may be revoked upon submission of a written application to the address of the location of ANO Skolkovo Forum.

If the subject of personal data withdraws consent to the processing of his personal data, ANO Skolkovo Forum undertakes to stop processing them and, if the storage of personal data is no longer required for the purposes of processing personal data, destroy personal data within a period not exceeding thirty days from the date of receipt of the said review.
